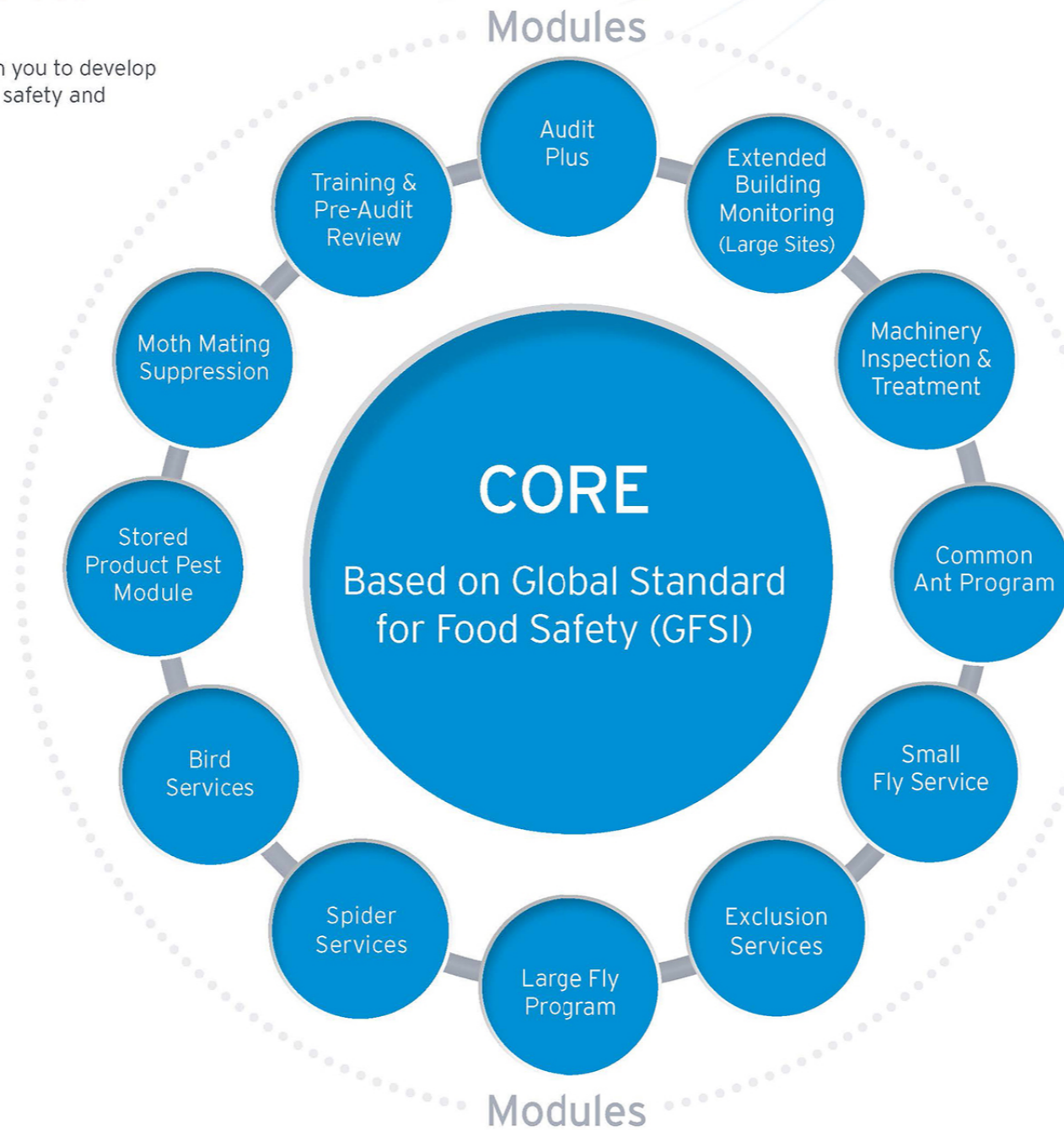
FoodProtect Core

▲ Moth Mating Suppression

This Module is designed to limit the impact of Stored Product Moths while long term solutions are put in place. A range of population reduction treatments are available, including organic ‘mating disruption’ which uses the latest pheromone research, to manage moth infestation effectively.

▲ Extended Building Monitoring

For large sites, we can provide a Building Monitoring Service to monitor and treat rodent activity specifically in Roof Voids and SubFloors. This Module ensures vigilance against rodent incursion from within the structure of the facility.

▲ Machinery Inspection and Treatment
